- B. SELLER agrees that if the Buyer's Prime Contract is modified by the end customer that SELLER will negotiate, in good faith, any changes that are required to meet the requirements of the Prime Contract.

 - Note 1 This clause applies only if the Seller is supplying an item that is an end product Under the Buyer's Prime Contract
 - Note 2 "Contracting Officer" means only "U.S. Government Contracting Officer"
